- District News Highlights
  - Following the cancellation of the PCA Fair due to the Govt shutdown, a new date has not been released. The Training Dept is looking at providing some separate classes or presenting some of the cancelled classes at DTrain.
  - 2. Recruitment and Retention are high priorities. Information on successful recruitment drives should be sent to COMO Wally Smith for sharing at National Level.
  - 3. All AUX duties, except for those requiring orders, are now authorized. COMO Mary Kirkwood has clarified 'authorized duties' by email to all members.
  - 4. Many members have asked how they can support our local CG Units during the shutdown. CDR Keenan advised that active duties members are still bound by ethical rules and may not accept cash donations directly. However, there are organizations
    - authorized to make loans available to CG personnel. The Coast Guard Mutual Assistance Fund has been supporting active duty personnel and donations to the organization would be welcome in support of this activity.
    - COMO Mary Smith has proved additional guidance and useful contacts to all members by email.

- 5. CDR Keenan has advised that DIRAUX is currently staffed by two personnel due to the shutdown. Replies to emails will be
  - delayed, no new ID cards will be issued and there is no outgoing mail. The galley on Coast Guard Island is also closed.

- 7. The new Risk management 2.0 course will be mandatory for all members qualified in the Operations Program and for all elected and appointed officers. FCs should encourage members to complete the on-line course Introduction to Risk Management (100202) available on the AUX LMS website.
- 8. A test of the Everbridge Alert System was conducted on Saturday 19<sup>th</sup> January. The response rate was 78% for D11N. As the Everbridge system draws contact details from AUXDATA, all members are reminded to ensure their contact details in AUXOFFICER are correct.
- All boat-crew and coxswains are advised that hours entered as code 22A (Operations Training/Qualifications) do not count towards the
   Operations Service Award.
